Agenda: Designed for all water systems required to have a sanitary survey of their water system by the Drinking Water and Groundwater Protection Division, this seminar covers all aspects of a sanitary survey and how the water system operator can prepare for one. Topics covered include regulatory issues, sources, treatment, distribution system, facilities, monitoring & reporting, and operator compliance. Sanitary surveys are designed to ensure that water systems are in compliance with the Water Supply Rule and provide safe drinking water to consumers.
