Topics will include replacing well pumps, booster pumps, control panels, treatment, tank inspections and rebuilds, and piping. These all will be presented through the lens of the challenge to keep the water running while improvements are being made. This will be followed by a discussion on how water systems can organize and manage their own pump station rebuild project.
